TOPIC: INCOTERMS 2010 ARE HERE

On January 1, 2011, Incoterms 2010 replaced Incoterms 2000 as the new authoritative text for determining how costs, risks, and other obligations are allocated to the two parties (seller/buyer) in a transaction regarding the delivery of goods. Modifications regarding obligations, risk transfer, and cost sharing have been made to the nine Incoterms carried forward from Incoterms 2000. Our Speaker Mr. Zoltan Zoltai will provide an overview for the old and new Incoterms.
